## Mental Health Awareness



Since 1949, Mental Health Awareness Month has been observed in May in the United States. It's a time to raise awareness about mental health and reduce the stigma associated with mental or behavioral health conditions.

The National Institute of Health (NIH) estimates that 51.5 million adults in the U.S. are living with a mental illness, yet less than half of them are receiving mental health services.

Caring for your mental health includes tending to your emotional, psychological and social well being. "Self-care looks different for everyone, and it is important to find what you need and enjoy. It may take trial and error to discover what works best for you. In addition, although self-care is not a cure for mental illnesses, understanding what causes or triggers your mild symptoms and what coping techniques work for you can help manage your mental health."
