African American cemeteries

The African American community can record the abandoned and unidentified cemeteries in their area to add them to the government records to allow for future landowner property knowledge of the cemetery. The community can also apply for historic cemetery designation, including the history, photographs, historic deed records, and a map of their cemeteries to protect them from some of the threats limiting them from remaining a permanent remainder of the African American community heritage. Also, forming a cemetery association or corporation will help the African American community create regulations and rules that protect their cemeteries and help raise tax-deductible funds to enable the maintenance, preservation, conservation, and clean-up efforts on their cemeteries. These steps help the African American community protect their cemeteries from various threats; therefore, educating the citizens on the importance of cemetery preservation is equally important. Citizen education involves teaching the community through workshops, community outreach, social media, and local non-profit PR campaigns.
